

ASSIGNMENT OF LEASE

PARCEL ID NOS. are not assigned to leasehold estates.

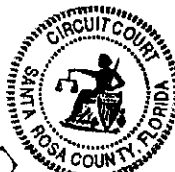
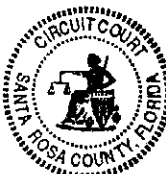
